5. The first name and surname of the person to be searched for plus at least one other item of information must be given.
6. Examples of search results can be found in the Internet under www.deutsche-auswanderer-datenbank.de
7. The client shall be informed of the result of the search in every case.
8. If the same name is found more than once during the search in the DAD, it may not be possible to identify the person with absolute certainty.

In this case the customer will receive a list of all the names that matched, together with the ages and the years of emigration, up to a maximum of 30 people. The customer can then have the search results printed out for selected people. The expense allowance of EUR 20 or US \$ 40 pays for one print-out. For any further print-outs EUR 5 or US \$ 15 will be charged.
9. In the case of a search for a surname or last residence the customer will receive a list of max. 100 persons. For any further list with up to 100 persons € 20 or \$ 40 will be charged.
10. The Deutsche Auswanderer-Datenbank (DAD) does not accept any responsibility for the completeness or accuracy of the data since the passenger manifests are historic, hand-written documents.
11. The DAD does not accept any responsibility for the accurate transfer of the data in the passenger manifests into the database. Problems may arise when entering the data as a result of unclear handwriting. Some details are not complete.
12. The client shall not be entitled to demand an accurate and clear search result. Therefore the client shall not be entitled to any reimbursement of the expense allowance.
